Dear Maplewood City DFL Delegate:

We have an **endorsing convention** set for **May 22, 2013** to endorse candidates for Maplewood <u>Mayor</u> and two seats on the <u>City Council</u>.

This letter is from two of your fellow delegates, **Margaret Ann Behrens** (currently our elected Ramsey County Soil and Water Supervisor) and **Diana Longrie** (former Mayor of Maplewood). **Together**, we stand behind our **DFL** principles of <u>inclusively</u>, <u>transparency</u>, and <u>diversity</u>.

Enclosed you will find copies of Margaret's **emails** as she attempts to obtain **delegate contact information**. The Maplewood City DFL chair states the list provided to Margaret is the same as that given to other candidates (we enclose a sampling of the list, pages 1 & 3 only).

**Note**: there are no telephone numbers or emails. Yet, one candidate seeking your endorsement, for city council, is making telephone calls – calls to unlisted (to the best of our knowledge) phone numbers which the DFL party collected at the 2012 city endorsing convention or at the caucus. Further, this hand-picked candidate is not a DFL delegate. She was asked to run at the request of DFL delegate, Nora Slawik, who is running for Mayor of Maplewood.

Lastly, we are <u>alarmed</u> by the **rush to push** through the **endorsement** of the **Insiders' "Dream Team"** at the expense of any and all candidates in our community that may wish to seek DFL endorsement. Our chair confirms, "The official call is the only announcement we will make." **That's not right!** That's not consistent with DFL values.

We ask you to join us! Level the Playing Field. <u>Demand</u> the endorsing <u>convention</u> be held after **June 4, 2013**, the last date to file – so that **ALL** who seek DFL endorsement can have an opportunity. <u>Their opportunity</u> is *in your hands*.
